RESUME OF BUSINESS TRANSACTED DURING THE SIXTH SESSION OF THE TWELFTH TRIPURA LEGISLATIVE ASSEMBLY

I. SUMMONS

In exercise of the powers conferred by clause (1) of Article 174 of the Constitution of India on 8th January, 2020 Shri Ramesh Bais, the Governor of Tripura summoned the Sixth Session of the Twelfth Tripura Legislative Assembly and Notification was accordingly issued.

II. DURATION OF THE SESSION

The Sixth Session of the Twelfth Tripura Legislative Assembly commenced from the 17th January, 2020 to 20th January, 2020 and the House was adjourned SINE-DIE by the Hon'ble Deputy Speaker on 20th January, 2020. In exercise of the powers conferred by sub clause (a) of clause (2) of Article 174 of the Constitution of India the session was subsequently prorogued by His Excellency the Governor of Tripura Shri Ramesh Bais vide order dt. 17th February 2020.

III. SITTING OF THE ASSEMBLY

The Tripura Legislative Assembly met under Rule 16 (1) of the Rules of Procedure and Conduct of Business in the Tripura Legislative Assembly House for 2 (two) day's sitting during the period from the 17th January, 2020 to 20th January, 2020 and in terms of hour it sat for 12 hours and 10 minutes only.

IV. GOVERNOR'S ADDRESS

On 17th January, 2020 the first day of the 6th Session of the 12th Tripura Legislative Assembly met at 11.00 A.M. Shri Ramesh Bais, Governor of Tripura arrived in the Assembly and addressed the House under Artical 176 of the Constitution of India and left the Assembly House at 11.40 A.M.

All the Opposition Members Walked-Out from the House in protests of the Governor's Address at 11.15 A.M.

At the conclusion of the Governor's address the House dispersed and reassembled after 15 minutes

VI. ANNOUNCEMENT BY THE CHAIR

On 17th January, 2020 the Hon'ble Speaker announced that a letter received from Shri Manik Sarkar, Hon'ble Leader of Opposition informing that he would not be present in the House on 17th January, 2020 for his pre-scheduled programme of the session and Shri Tapan Chakraborty, Hon'ble Member would act as a Leader of Opposition and perform all duties and functions of the Leader of Oppsition in the house.

The Hon'ble Deputy Speaker announced in the House that the on going Assembly Session would be end on the 20th January, 2020. So, the Hon'ble Members were requested not to submit Reference notice and Calling attention notice on 20th January, 2020.

VII. MATTER RAISED BY MEMBERS

The Hon'ble Members Raised the following matters on the different sittings of the Session:-

1) On 17th January, 2020 Shri Diba Chandra Hrangkhawl, Hon'ble Member stood up and drew the attention of the Hon'ble Minister-in-charge of the Tribal Welfare Department through the Hon'ble Speaker to the observation note submitted by the Scheduled Tribes Committee of the Tripura Legislative Assembly about stipend through the D.P.T system for the drop out S.T students in the State.

Shri Sudip Roy Barman, Hon'ble Member took part in the discussion.

Shri Rampada Jamatia, Hon'ble Member also took part in the discussion.

Shri Mever Kumar Jamatia, Hon'ble Minister-in-charge of the Trible Welfare Department replied to the matter.

Shri Brisaketu DebBarma, Hon'ble Member wanted to know to the Hon'ble Minister-in-charge of the Tribal Welfare Department through the Hon'ble Speaker wheather the matter is within the State list or the Union list?

Shri Jishnu DevVarma, Hon'ble Deputy Chief Minister who is also the Minister-incharge of the Finance Department also replied to the matter.

2) On 20th January, 2020 Shri Asish Kumar Saha, Hon'ble Member stood up and raised a matter through the Hon'ble Speaker and said that he was absent in the House on 17th January, 2020 but came to know from a news item published in the local news papers that the Hon'ble Deputy Speaker used a word to the specific Hon'ble Member and was very much shocked. Hon'ble Member also demanded that the word be expunged from the proceedings of the House.

(The Motion was adopted by the House unanimously)

All the Opposition Members came back in the House after Walk-Out at 1.05 P.M. and join in the Business of the House.

XI. REFERENCE PERIOD

During the 'Reference Period' on the different sittings of the Session, 3 (three) matters of urgent public importance were raised by the Hon'ble Members drawing the attention of the Hon'ble Ministers concern. The Hon'ble Ministers concerned made statements on those matters in details of which are given in the APPENDIX - I.

XII. CALLING ATTENTION

During the Session on the defferent sitings, 3 (three) Calling Attention notices on those matters of urgent public importance were admitted by the Hon'ble Speaker. The Hon'ble Ministers concerned made statements on those matters in details of which are given in the APPENDIX - II.

XIII. RATIFICATION OF THE CONSTITUTION (ONE HUNDRED AND TWENTY SIXTH AMEMDMENT) BILL, 2019 AS PASSED BY BOTH THE HOUSE OF THE PARLIAMENT.

On 17th January, 2020 the Hon'ble Deputy Speaker requested to the Hon'ble Chief Minister to move the Resolution.

Shri Biplab Kumar Deb, Hon'ble Chief Minister moved the Resolution regarding ratification of the Constitution (One hundred and twenty sixth Amendment) Bill, 2019 as passed by the both Houses of the Parliament.

The Resolution is –

"That this House retifies the amendment to the constitution of India falling within the purview of clause (d) of proviso to clause (2) of Article 368 proposed to be made by the constitution (One Hundred and Twenty Sixth Amendment) Bill, 2019 as passed by both the House of Parliament."

On 17th January, 2020 Shri Jishnu Dev Varma, Hon'ble Deputy Chief Minister who is also the Minister-in-charge of the Finance etc. Department laid a copy of the Statement relating to promulgation of "The Tripura State Goods and Services Tax (Second Amendment) Ordinance, 2019 (The Tripura Ordinance No. 03 of 2019) on the Table of the House.

XVI. LAYING OF GOVERNOR'S ADDRESS

On 17th January, 2020 the Secretary, Tripura Legislative Assembly laid a copy of the Governor's Address through the Hon'ble Speaker on the Table of the House.

XVII. LAYING OF MESSAGE AS RECEIVED FROM THE RAJYA SABHA SECRETARIAT

On the 17th January, 2020 the Hon'ble Deputy Speaker requested to the Secretary, Tripura Legislative Assembly to lay a copy of -"The Constitution (One Hundred and Twenty sixth Amendment) Bill, 2019" as passed by the both Houses of the Parliament alongwith a copy of the letter as received from the Rajya Sabha Secretariat on the Table of the House.

The Secretary, Tripura Legislative Assembly laid a copy on the above mentioned subject matter through the Hon'ble Deputy Speaker on the Table of he House.
