RESUME OF BUSINESS TRANSACTED DURING THE FOURTH SESSION OF THE THIRTEENTH TRIPURA LEGISLATIVE ASSEMBLY

I. SUMMONS

In exercise of the powers conferred by clause (1) of Article 174 of the Constitution of India on 13th February, 2024 Shri Indrasena Reddy Nallu, the Hon'ble Governor of Tripura summoned the Fourth Session of the Thirteenth Tripura Legislative Assembly and Notification was accordingly issued.

II. DURATION OF THE SESSION

The Fourth Session of the Thirteenth Tripura Legislative Assembly commenced from the 1st March, 2024 and continued till 5th March, 2024. The House was adjourned SINE-DIE by the Hon'ble Speaker on 5th March, 2024. In exercise of the powers conferred by sub clause (a) of clause (2) of Article 174 of the Constitution of India, the Session was subsequently prorogued by His Excellency the Hon'ble Governor of Tripura Shri Indrasena Reddy Nallu, with effect from the 20th June, 2024.

The Tripura Legislative Assembly met under Rule 16 (1) of the Rules of Procedure and Conduct of Business in the Tripura Legislative Assembly House for 3 (Three) day's sitting during the period from the 1st March, 2024 to 5th March, 2024 and in terms of hour it sat for 19 hours 45 Minutes.
