

On 10th January, 2025 with consent of the Hon'ble Speaker Shri Sudhangsu Das, Hon'ble Minister-in-charge of the Welfare of the Schedule Caste Department moved for leave of the House to introduce the Government Resolution:

"Whereas to abolish the dehumanizing practice of manual scavenging of human excreta and to eliminate as well as ban the further proliferation of dry latrines, the Parliament in accordance with the Resolution as passed by the Tripura Legislative Assembly and by the Legislatures of Andhra Pradesh, Goa, Karnataka, Maharashtra & West Bengal in pursuance of clause (1) of Article 252 of the Constitution had enacted "The Employment of Manual Scavengers and Construction of Dry Latrines (Prohibition) Act, 1993 (No. 46 of 1993);

And Whereas, the aforesaid law have not proved adequate in eliminating the twin evils of insanitary latrines and manual scavenging, Parliament in 64th year of Republic of India has enacted "The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013" (No. 25 of 2013);

And Whereas, due to such enactment of Central Act No. 25 of 2013, the Act No. 46 of 1993 has outlived its utility and become redundant;

And Whereas, "The Employment of Manual Scavengers and Construction of Dry Latrines (Prohibition) Act, 1993" (Central Act No. 46 of 1993) was made under Article 252 of the Constitution, thus its repeal could be done only in accordance with the provisions of Article 252;

Now, Therefore, in exercise of the powers conferred by Article 252 of the Constitution of India, this House hereby resolves that the resolution with respect to repeal "The Employment of Manual Scavengers and Construction of Dry Latrines (Prohibition) Act, 1993" (No. 46 of 1993) should be made to enable Parliament to get it repealed."

#### **XVII.** GOVERNMENT RESOLUTION - Passed.

& West Bengal in pursuance of clause (1) of Article 252 of the Constitution had enacted "The Employment of Manual Scavengers and Construction of Dry Latrines (Prohibition) Act, 1993 (No. 46 of 1993);

And Whereas, the aforesaid law have not proved adequate in eliminating the twin evils of insanitary latrines and manual scavenging, Parliament in 64th year of Republic of India has enacted "The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013" (No. 25 of 2013);

And Whereas, due to such enactment of Central Act No. 25 of 2013, the Act No. 46 of 1993 has outlived its utility and become redundant;

And Whereas, "The Employment of Manual Scavengers and Construction of Dry Latrines (Prohibition) Act, 1993" (Central Act No. 46 of 1993) was made under Article 252 of the Constitution, thus its repeal could be done only in accordance with the provisions of Article 252;

Now, Therefore, in exercise of the powers conferred by Article 252 of the Constitution of India, this House hereby resolves that the resolution with respect to repeal "The Employment of Manual Scavengers and Construction of Dry Latrines (Prohibition) Act, 1993" (No. 46 of 1993) should be made to enable Parliament to get it repealed."

বিশ্ব দাবা প্রতিযোগিতায় গুকেশের এই অসামান্য কৃতিত্ব তাঁর একাগ্রতা, কঠোর পরিশ্রম এবং কৌশলগার দক্ষতার প্রতিফলন। তাঁর এই ঐতিহাসিক সাফল্য শুধুমাত্র তাঁর পরিবারকেই গর্বিত করেনি, পুরো ভারতবর্ষে-জন্যও এক গৌরবের বিষয় হয়ে উঠেছে। বিশ্বের সর্বকিনিষ্ঠ দাবাড়ু হিসাবে বিশ্ব চ্যাম্পিয়নের খেতাব অর্জন করে গুকেশ ডোম্মারাজু তরুণ প্রজন্মের জন্য এক অনুপ্রেরণার উৎস হয়ে থাকবেন।

Shri Gopal Chandra Roy, Hon'ble Member with regret to informed to the Hon'ble Chief Minister through the Hon'ble Speaker that some miscreants destroyed the Yatri Shed near Gandhi School last light. The shed was constructed by him through the MLA development fund for mothers and childrens and as well as he demand for investigation in this incident.

Shri Jitendra Choudhury, Hon'ble Leader of Opposition stood up and drew the attention of the Hon'ble Chief Minister on the Old Journalists Pension Scheme which was increased Rs. 1,000/- to Rs. 10,000/- but very little number of old Journalists could benefited due to the hike eligible criteria. As well as he requested to the Hon'ble Chief Minister to consider the criteria for the interest of old Journalists in the State.

Shri Birajit Sinha, Hon'ble Member drew the attention of the Hon'ble Chief Minister through the Hon'ble Speaker said that a long high baraze constructed by Bangladesh near Kailashahar border that would be flood flowed over in Kailashahar during in comming monsoon and requested to the Hon'ble Chief Minister to take initiative in this regard.

Shri Sudhangshu Das, Hon'ble Minister also took part in the discussion in support to the Hon'ble Member.

Professor Dr. Manik Saha Hon'ble Chief Minister constructive replied to the points.
